

PRIVACY POLICY

Because we gather certain types of information about our users, we feel you should fully understand our policy and the terms and conditions surrounding the capture and use of that information. This privacy statement discloses what information we gather and how we use it.

GENERAL

We collect and store statistics and other information about the online activities of our visitors on an aggregated (collective) basis. In most instances, we do not obtain personally identifiable information about you.

USE AND DISCLOSURE OF INFORMATION

We may disclose aggregated information about our site to third parties for purposes of analyzing our Web site traffic and optimizing how we lay out content on the site.

COOKIES AND OTHER TRACKING METHODS

Cookies are small pieces of information stored on your hard drive, not on our site. We use cookies or, in a limited number of cases, IP addresses, for a number of reasons. First, cookies allow you to store your password without having to constantly re-enter it. Second, cookies allow us to better understand how users use our site. You are always free to decline our cookies if your browser permits, but some parts of our site may not work properly if you do.

Please note that if you provide any information on your own to parties who provide service to us or to any other sites you encounter on the Internet (even if these sites are branded with our branding), different rules may apply to their use or disclosure of the personal information you disclose to them. We encourage you to investigate and ask questions before disclosing information to third parties.

LIMITS ON OUR ABILITIES

Although your privacy is important to us, we cannot ensure that your private communications and other personally identifiable information will not be disclosed to third parties. For instance, we may be required to disclose information to Government agencies or representatives or third parties under certain circumstances, or third parties may unlawfully intercept or access transmissions or private communications. Additionally, in the event we need to investigate or resolve possible problems or inquiries, we can (and by use of our site you authorize us to) disclose information about you to private entities, law enforcement, or other Government officials as we, in our discretion or as may be required under law, believe necessary or appropriate.
